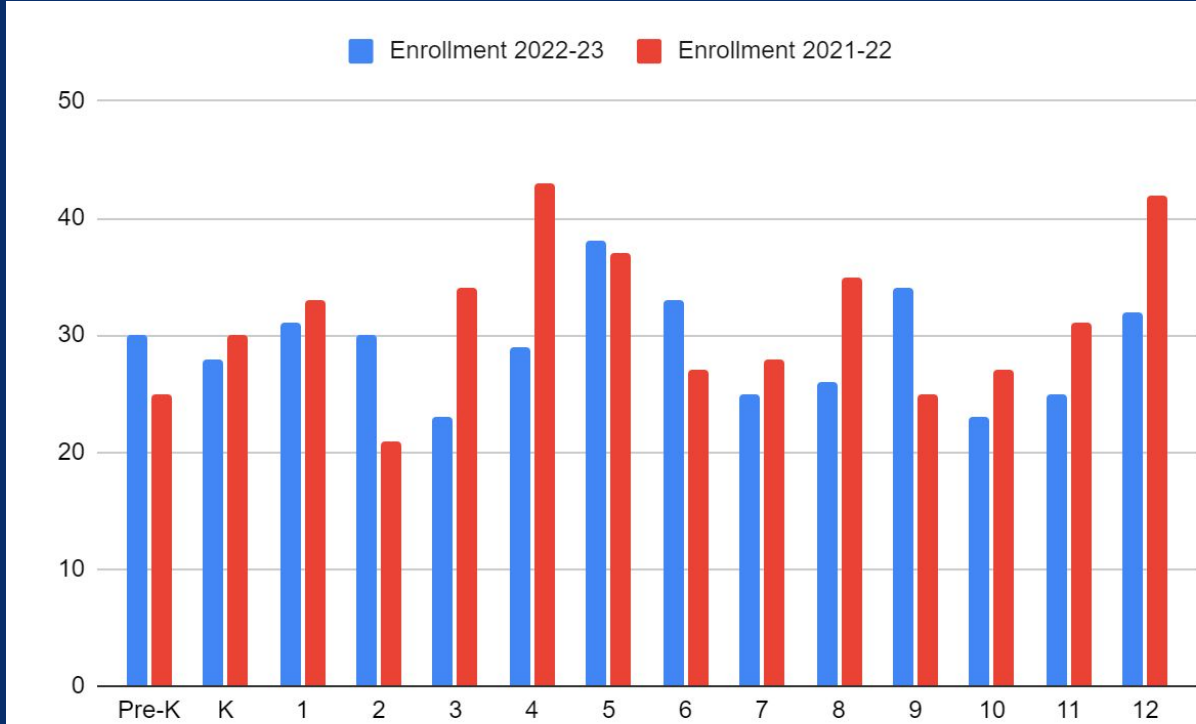
Advocacy Strategy
