# Grants Update

- ESSER: Has been approved- The grant project period ends 9/30/2024 all funding to be fully liquidated by 10/30/2024.
- UPK: The districts 2024-25 State-Administered Prekindergarten Application has been approved.
- ESSA Consolidated Application (Title I, II, IV): Submitted and still under review.
- ESD: Approved for the 2024-25 school year. Session 1 sign ups are underway for first 5 weeks of programs.

# Cell Phone Policy 2025-26
