
Overview

The Student Services Department oversees a variety of programs and supports designed to meet the diverse needs of all students. This includes managing 504 Plans, Individualized Education Programs (IEPs), and preschool special education (CPSE), as well as ensuring compliance with state and federal regulations, providing accommodations, and supporting student success across academic, social, and emotional domains.

Overview of Student Programs

- Pre-K Enrollment: 29 students participating in early education programs designed to build foundational skills.
- 504 Plans: 24 students receiving accommodations to support access to the general education curriculum.
- Individualized Education Programs (IEPs): 75 students receiving specialized instruction and services tailored to their unique needs.
- **CPSE (Preschool Special Education):** 5 students engaged in early intervention services to support developmental milestones and readiness for school.

- Focuses on school engagement with parents in the special education process.

Preparing for Annual Reviews

What is an Annual Review?

- A yearly meeting required for every student with an IEP (Individualized Education Program).
- Purpose: To review the student's progress, update goals, and make necessary adjustments to services or supports.
- Ensures the IEP continues to meet the student's needs and complies with state and federal requirements.

Preparing for Annual Review Continued...

Our Preparation:

- Reviewing student progress data.
- Collaborating with teachers, service providers, and families.
- Ensuring all documentation is accurate, complete, and ready for discussion.

Goal:

To ensure each student's IEP is tailored to their current needs and supports their success in the coming year.






STATE OF THE DISTRICT 2025:FACILITIES






